# Officer reports:

**Exchequer (Isadora)** – The Barony checking balance is \$14,029.45. There is one outstanding check to Tofa (\$5.42). Storage rent is paid through December.

**Minister of A&S (Azalais)** – This month's A&S meeting will take place the 10<sup>th</sup>. The topic will be dances of the Middle Ages. See the Guild reports for Melodians news. Please submit award recommendations!

**Chronicler (Tófa)** – The Runestaff deadline remains the 15<sup>th</sup>. If everyone sends their contributions early enough, Tofa can sketch some marginalia to accompany those articles.

**Herald (Istvan)** – Is the new Herald! [This is a Great Office and therefore filling the position is a requirement for us to continue as a Barony. Tófa]

**Media Cryer (Tófa)** – Is the new Cryer and needs access to the social media accounts to begin publishing event news online.

**Gold Key (vacant)** – The question was raised regarding who would like to coordinate GK. Storage place is secured, in case the coordinator lacks space.

**Chatelaine (Laurencia)** – The Walt Library Ren Faire is Saturday Dec 6<sup>th</sup>. Please join us! Contact the library if you need to set up on Friday. Pizza, soda, and water will be provided. NO WEAPONS. There will be a discussion about ConStellation (event is in March) on Dec 17<sup>th</sup>.

**Web Minister (Laurencia)** – Yule Court is on the Baronial calendar but is not a separate page. A Coronation page is in the works.

Minister of Youth (Adel) – Half-Troll has submitted his background check paperwork so he can help with youth activities during Cattle Raids.

**Largess Coordinator (Martine)** – The next fifth Wednesday is New Year's Eve. We will not have a meeting that night, so April 29<sup>th</sup> is the next Largess Night. Tentative plans, i.e. newcomer's gift items, were briefly discussed.

Knights Marshal (Volkmar) – There has been little activity. The Lincoln Public Schools system requires they are included as a named insured prior to booking an activity at one of the LPS properties. The insurance issue will be discussed at the next Finance Committee meeting on Dec 17<sup>th</sup>. [Reminder from last month's discussion: LPS elementary gymnasiums can be rented for \$55 for two hours. Tófa] The insurance certificate can cover a whole year of practices, so obtaining one at the start of the new year should cover both spring and fall/winter indoor practice seasons. There was a discussion about updates to multiple fighter rules; fighters, please familiarize yourself with the current standards. There are changes to the armor requirements, including hand protection. There is now an expiration date on authorizations. Fighters, including knights, must reauthorize every four years. Expect to answer questions throughout the four-year period as part of the ongoing practice of maintaining your authorization.

**Archery (Yoichi)** – There is a new seasonal society archery challenge. Yoichi has sent an email to gauge interest. Please reply ASAP so he can look into booking an indoor archery site.

### New business:

- 1. We still need to propose a Masters of the Duel date.
- 2. Insurance updates that affect Cattle Raids:
  - a. Per Society, there are new rules for 2026 equestrian insurance certificates that are locationspecific. The insurance covers both events and practices at specified locations.
  - b. In addition, the cost of insurance has increased to \$1200 per certificate. Half of the cost will be paid by Kingdom and half by the group hosting the equestrian event. A fund was available two years ago for host groups. Access and distribution of the funds was determined by the group event and the number of horses participating.
  - c. There is a maximum of 60 certificates to be issued worldwide. Calontir gets three of these certificates, and Mag Mor's Cattle Raids gets one of those certificates.
  - d. We need to talk with the equestrians to determine where they want to focus events.

# **Financial Committee Meeting Minutes**

Committee in attendance: Heidi Hillhouse, Matthew Parker (via Zoom), Opal Doerr, Emma Martin, Heidi Copeland, Vivian Hancock, and Chris Stuart.

On December 17, 2025, the Mag Mor Financial Committee met at Walt Library. The meeting opened at 6:34 PM.

Baronial Business Cards: Lady Laurencia, Chatelaine, requested approval for purchasing more Barony business cards – 250 for under \$25.00. After discussion, HE Asa, the Seneschal, offered to have that expense come out of her 2025 office budget, which hadn't yet been used. All agreed this was a good plan – no vote needed.

Insurance Certificate for Winter Fighter Practice Site: Baron Uji, HE Mag Mor, described his plan to rent gym space for fighter practice from Lincoln Public Schools (LPS). From his previous inquiry, the cost of using an LPS elementary school gym would be \$50 per use. Based on our normal winter fighter practice schedule, that would be \$100 per month, which is the amount we paid in the past and is already budgeted, so this did not need Finance Committee approval.

However, LPS requires being named on the insurance certificate, so he asked the Finance Committee for approval for the \$75 expense for the Certificate of Insurance naming LPS in advance of his further contact with LPS to identify a specific location.

Baron Uji also plans to put in a bid for the Kingdom "Masters of the Duel" event. If the date/locations align, he will include that event on the same Insurance Certificate. If not, he'll return to the Committee for approval of another Insurance Certificate, naming LPS.

Lady Cera moved that the Finance Committee approve the \$75 expense for an Insurance Certificate naming Lincoln Public Schools for the purpose of the Barony renting an auditorium as Mag Mor's winter martial activity site.

Lady Emma seconded the motion. The motion carried unanimously, with 7 votes.

Meeting ended at 6:50 PM.

# **Previous Financial Committee Meeting Minutes**

Committee in attendance: Heidi Hillhouse, Pam Cole (via Zoom), Opal Doerr, Emma Martin, Heidi Copeland, Vivian Hancock, and Chris Stuart (via email).

On November 12, 2025, the Mag Mor Financial Committee met at Eisley Library. The meeting opened at 6:43 pm.

The exchequer provided handouts of the proposed 2026 Baronial Budget to all attending the meeting, including general populace. After questions and discussion – mostly for clarification – Lady Cera moved that the proposed 2026 budget be approved. Lady Emma seconded the motion. The motion carried - 7 votes for and 0 votes against.

Lady Leofwyna described her bid for Baronial Yule Court on Sunday, Jan 24, 2026, at St. Mark's on the Campus, 1309 R Street, Lincoln, NE. It will include Baronial Court, the Baronial A&S and Bardic Championships, an optional white elephant gift exchange, a table decorating contest, a youth activity, and a potluck meal. For the meal, main entrees will be provided, with populace bringing side dishes or desserts.

A budget of only \$20 was requested for the bid – an amount not requiring an official vote. Nevertheless, the bid was approved by consensus of the Financial Committee, as well as all other attendees.


